Such insurance shall be written in the following minimum amounts:

GMP shall be named as additional insured under all policies required with the exception of the Worker's Compensation policy. All insurance policies required to be carried hereunder shall contain a waiver of subrogation as to GMP, its agents, employees and the parties for which it is operating. The carrier of the insurance policies required shall agree that the insurance required shall be considered primary insurance and all insurance carried by GMP, its agents, employees, and the parties for which it is operating, shall be considered secondary in relation thereto. Any and all deductibles in the above described insurance policies shall be assumed by, for the account of, and at the sole risk of the contractor. GMP reserves the right to amend these minimum requirements as may be necessary.
