² Total Capital includes all costs for equipment, labor, and materials. Projects are completed by external contractors and include the internal labor for GMP-specific requirements to control and isolate GMP equipment for safe work (switching and tagging) and, for projects underway prior to Order as referenced in the proceeding, include the initial cost for distribution design and engineering; total for both is \$989,952.25 or 2.9% of \$34,460,842.08
